**MEMBERS OF MONTGOMERY FOREST NO. 134**

The following changes in the By-Laws of your Forest will be acted upon at our regular meeting, October 15, 1949. Be present for the Meeting.

**CHANGES AND REWRITING OF BY-LAWS AND AMENDMENTS  
OF**

**MONTGOMERY FOREST NO. 134  
SILVER SPRING, MD.**

Substitute for the PREAMBLE which was deleted by the Supreme By-Laws Committee, the following PREAMBLE as written by them:

"This Forest shall be governed by, first, the Constitution, By-Laws, Regulations and Edicts of the Supreme Forest of the Tall Cedars of Lebanon of the United States of America, incorporated under the Laws of the State of New Jersey; and is constituted by virtue of a charter granted 19 by the Supreme Forest, from which it derives all its powers and privileges; and second, by the following By-Laws:"

In all cases where the word "CONSTITUTION" appeared, it has been deleted as requested for the reason that the Forest operates under the Constitution of the Supreme Forest and therefore cannot have a Constitution of its own.

Substitute for Section 2, ARTICLE IV, (Membership) which was deleted by the Supreme Forest, the following as written by them:

"Second: Any person possessing the necessary qualifications under our Supreme Forest By-Laws, and recommended by two members of this Forest, is eligible to membership".

Listing the elective officers in the sequence in which they appear in the Supreme Forest By-Laws and the addition of a GUIDE.

Paragraph 7 under ARTICLE V. (Officers) reading:

"The circulation or distribution of resolutions, by circular letters, tickets or any printed or written matter, suggesting or advocating, recommending or containing the names of proposed candidates for office in this Forest is prohibited. Nominations for office, or any remarks setting forth the qualifications of a member for office at a meeting where election of officers is held, are prohibited."

The last sentence, "Nominations for office, or any remarks setting forth the qualifications of a member for office at a meeting where election of officers is held, are prohibited," shall be deleted from the By-laws.

ARTICLE VI (Meetings), fourth paragraph, reading: Notice of annual meeting shall be sent to all members of this Forest at least thirty (30) days before date of meeting." to be deleted.

Add to ARTICLE VII, a section numbered, 35, as written by the Supreme Forest as follows: "GUIDE shall have charge of the candidates at the Ceremonial Sessions, and his duties shall be such as are designated in the Ritual, and as may be required by the Grand Tall Cedar."

Add to Section 1, ARTICLE XII, a paragraph as written by the Supreme Forest By-Laws Committee to read as follows: "Petitions for membership WILL NOT be accepted from any person unless he possesses the necessary qualifications under our Supreme Forest By-laws, or if charges are pending against him in any other organization."

(c) of section 5, ARTICLE XIII, deleted by the Supreme Forest and the following substituted by them: FAILURE TO POSSESS QUALIFICATIONS FOR MEMBERSHIP. If and when a member of the Order shall fail to possess the necessary qualifications for membership, he shall automatically be suspended, and the Scribe shall strike his name from the membership list. (Art. VIII.

Cont'd from preceding page  
Section 12A, By-Laws Supreme Forest).

Section 1, ARTICLE XV, to be changed as follows:  
Delete the following words, "two years dues within twelve (12) months from date of suspension.", and substitute, "the current year's dues."

Delete the following words, "and dues which may be due, within twelve (12) months from date of suspension." The new section as rewritten, to read: "A member suspended for non-payment of dues, shall be automatically reinstated to membership, upon payment of the current year's dues. A member suspended for non-payment of assessment shall be automatically reinstated upon payment of assessment in full."

Delete Sections 3 and 4 of ARTICLE XV.

Section 2, ARTICLE XVI, deleted by the Supreme Forest and the following substituted as written by them:

"The annual dues shall be five dollars (\$5.00), payable in advance on or before January 1 of the year for which due. Tall Cedar good standing card will not be issued by the Scribe unless member produces card showing that he possesses the necessary qualifications under our Supreme Forest By-Laws. Should a member fail to produce such a good standing card, dues shall not be accepted."

Section 9, ARTICLE XXI, the first sentence which reads: "The election of officers shall be had by paper ballot without nomination, as provided in the By-Laws of this Forest." to be changed to read as follows:

"The election of officers shall be had by paper ballot, by nomination, as provided in the By-Laws of this Forest."
