MESSAGE FROM THE CEDARETTE PRESIDENT;

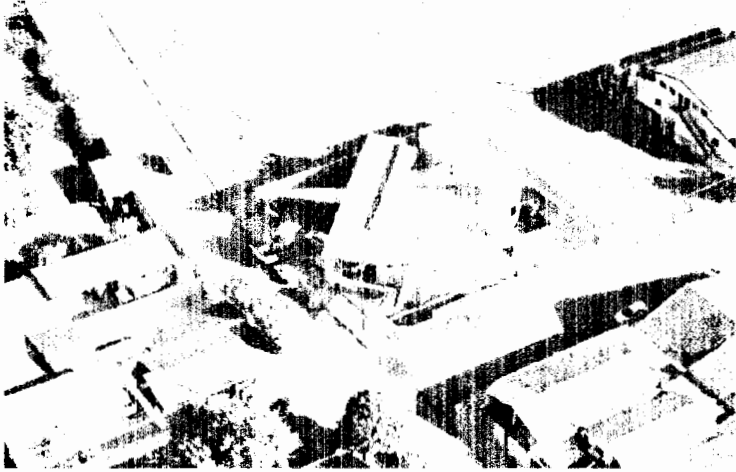
I want to thank you for electing me to be your President for the coming year. I will do my best to serve you all and have some fun.
